Two scientology websites were illegally accessed and modified.

Sensitive Investigative Matter

Facts of Incident:
On 10/31/2009 the scientology website scientology-europe.org was hacked, defaced, and ultimately modified to redirect to an anti-scientology website, whyaretheydead.org. The website was modified using a program called C99shell. This program was placed on the webserver and a URL to access the program was posted on the messageboard 888chan.org. Any user who accessed the URL pointing to C99 would have access to modify files on the webserver without entering a username and password.

On 11/03/2009 another scientology website, Freedom-Belgium.org, logged attempts to access the C99shell program. The Freedom-Belgium.org website is hosted on the same computer as scientology-europe.org

Webserver logs show that several of the IP address who accessed the C99Shell program are located in the United States

Synopsis: To close the above captioned case.

Details: On October 31, 2009 the Scientology website Scientology-Europe.org was hacked, defaced, and ultimately redirected to the Anti-Scientology website Whyaretheydead.org. The Scientology-Europe.org website was modified using a program called C99shell. This program was placed on the webserver without the website administrator's knowledge. A URL to access C99Shell was posted on the messageboard 888chan.org, a message board frequently used by the internet group Anonymous. This URL allowed any user who accessed the messageboard the ability to modify files on the Scientology-Europe.org webserver without entering a username and password.

On November 3, 2009 another Scientology website, Freedom-Belgium.org which is hosted on the same webserver as Scientology-Europe.org, logged attempts to access another version of the C99shell program. These logs show that several of the IP address that accessed the C99Shell program are located in the United States. Scientology's headquarters is located in Southern District of California.

Further analysis of the IP logs provided by the Church of Scientology determined that all but one of the IP addresses located inside the United States that participated in the attack against the Church of Scientology utilized an anonymity program

such as TOR to mask their identity. No further investigation was conducted on these IP addresses.

The sole IP address located in the U.S. that participated in the attack against the Church of Scientology was [redacted]. Subscriber information provided by SBC Communications showed this IP address was registered to [redacted] residence address [redacted] [redacted] at the time of the attack.

The writer interviewed [redacted] and learned that in addition to [redacted] three children and wife, at least eight other individuals lived at his residence during the time of the attacks. Many of the individuals were college friends of [redacted] and [redacted] could not provide their full contact information. Furthermore [redacted] stated he often left his wireless router open for periods of time so that anyone could access the internet through his connection.

Writer requests the above titled case be closed due to lack of investigative leads.
