Synopsis: Open new case and associated Grand Jury sub-file related to [redacted]

Administrative: Open new case and sub-file to house Grand Jury materials associated with [redacted] per telcal on 03/15/2007, between Assistant United States Attorney (AUSA) [redacted] and writer.

Details: The Church of Scientolgy provided writer with 158 pages of e-mails that involved harassment and/or threats. From this material, writer was able to obtain ten (10) e-mails pertaining to harassment and/or threats. Writer focused on key words inside of the e-mails that pertained to specific threats to the church itself or to specific members of the church. The e-mails are the following:

1. Tab 34 (May 31, 2006), "down with the hate sites or down you go."
2. Tab 38 (Jan 26, 2007), "maybe you want to interview him before he's gone for good? So one of you must bleed."
3. Tab 41 (Jan 30, 2007), "We bring pain to those who cause it. Their perceived delight is their ultimate demise." "We old him he'd have to do better or end up being destroyed" [redacted] punishment is just beginning." [redacted] She must be punished."
4. Tab 42 (Feb 20, 2007), [redacted] should be hurt. [redacted]"

5. Tab 44 (Feb 20, 2007), "Your pain is NOTHING compared to what will happen to them. The left hand will crush them."

6. Tab 45 (Feb 20, 2007), [redacted] and others will be writhing on the floor in complete agony and NOTHING can help them. The left hand cannot be stopped." b6

7. Tab 46 (Feb 20, 2007), "But the evil that RFW must be destroyed, even if [redacted] must be sacrificed. It is all in the pain."

8. Tab 47 (Feb 20, 2007), "The hatemongers of Religiousfreedomwatch will prefer a bath in molten lead compared to what is about to happen to them."

9. Tab 49 (Feb 20, 2007), "What is that at your door?"

10. Tab 50 (Feb 20, 2007), "A quick death by a sharp sword is FAR too good for [redacted] will not die she will suffer until she excretes the last drop of the polluted essence of Greenway." b6

The aforementioned e-mails were submitted to AUSA [redacted] for review. Thereafter, she stated that there were threats inside the e-mails against specific members of the church and wanted further investigation into this matter.

In order to store Grand Jury material separate from other documents pertinent to the case, writer is requesting that a new case be opened to address cyber internet threats towards the Church of Scientology and that a Grand Jury subfile also be created.
